## **Council District 8: Ron Gibson**

- Focus: Improving neighborhood streets, and eliminating vacancies.
- Gateway to Life initiative at 38th & Emerson: \$48M project will provide 250 apt units and rehabilitate 12 vacant buildings.
- Habitat for Humanity at 46th & Millersville Rd: Brick will now be added to the facades of the proposed 10-unit development.

### **Council District 3: Dan Boots**

- The Nickel Plate Trail: Advancing with \$12M in Next Level Trails and bridge construction funding through INDOT and Federal grants.
- Trail-Oriented Development: Approved by the Council; focuses on denser, mixed-use nodes and walkability near trails and bus lines.
- Litter abatement pause: KIB is using MAC reports to assign Keys2Work to major thoroughfare cleanups, but Binford is not on their list.
- <u>Stay informed</u>: Sign up for his e-newsletter and follow on social media, rather than emailing directly.

### **Council District 9: Keith Graves**

- <u>38th & Arlington</u>: The area is strengthening with investments from Cook Medical, Eskenazi Health, and Indy Fresh Market.
- Arlington Middle School: Now open as an IPS STEM program facility for grades 6-8, with state-of-the-art modifications ongoing.
- 46th & Arlington: A promising new project is in development, but details are not yet available to the public.

# Millersville Connectivity Planning and the Missing 56th Street Links: Susy Haber

The history of and needs for completion of the engineered third phase of the 2013 protected bike/walk trail project on 56<sup>th</sup> St between the light at Cathedral High School and Old Colony Rd (I-465) were reviewed, as well as a protected path over I-465 to connect MFCV with Lawrence. Steps outlined to advance these goals:

- Partner with non-profits to raise funds to make it happen.
- Engage in a broad letter-writing campaign that includes individual voices, not just those of neighborhood association presidents.
- Recognize that implementation may have to be achieved in sections, though the ultimate goal is to complete it as one.
- Do not be discouraged. Persist if denied, and keep trying.

### Dan Boots' comments

- The City does not have enough money in the budget to consider this; it will have to be accomplished with matching funds.
- It will take time. Funding for the Nickel Plate Trail through NLT took six (6) years.
- Demonstrate why the 56th Street Project needs to be funded, and how volunteers support the area through their regular trash pick-ups.

# Indianapolis Neighborhood Resource Center's new 2024 \$10,000 "Neighborhood Grant" to MFCV will provide funds to:

- Remove 60 dead & dying bushes from 3 Fall Creek trail parking area planting beds NE of Kessler Blvd and replant with professionally recommended new species on October 16, with the assistance of MFCV volunteers and Hoosier Youth Challenge Academy cadets.
- Emerson Way Bridge / Fall Creek Greenway rehabilitation: Continue development of a native prairie where previously invasives overrun. Professionally control re-growth of invasives, and continue reseeding with prairie grasses and flowers.
- Fall Creek Overlook and Preserve Sculpture Garden: Replace native grasses, flowers and mulch lost to winter attrition and flooding.
- Gateway Medians: Revitalize by renewing perennials and replenishing gravel and river rock. Professionally weed control all planted beds.

# City of Lawrence: LeAndre Level

The new Administration met with MFCV's Board in February to discuss a pedestrian sidewalk over I-465 to connect the Lawrence and Millersville communities, linking to existing sidewalks in Lawrence and providing Lawrence Twp students on the west side of I-465 safe access to schools, work and trails, as well as healthy opportunities for families in both communities.

- American Structurepoint is updating Lawrence's pedestrian plan, which will include an opportunity for public input.
- Lawrence secured a \$5M Next Level Trails grant to fund a Fall Creek Trail extension from Ft. Harrison State Park to the Geist loop trail.

# Millersville Village: Tom Eggers

The transformation from a fading business center in 2009, when Cac Diehr organized MFCV to revitalize the Village after O'Malia's departure, to the current growth of 75 leased Village spaces and a variety of businesses was highlighted.
